















- **2. Bridging the Gap between Industry and Curriculum Demands:** Another key finding from the feedback analysis is the importance of bridging the gap between industry requirements and the curriculum. Faculty members can benefit from guidance and suggestions on how to update their teaching methods to ensure that graduates are well-prepared for the demands of the job market. Collaborative efforts with industry professionals and regular curriculum reviews are essential steps in achieving this alignment.
- **3. Enhancing Library Resources:** While this point does not directly reach the 40% threshold, it is still a noteworthy concern. Adequate access to educational resources, including books in the library, plays a vital role in supporting the learning process. Ensuring that the library is well-stocked and regularly updated with relevant materials can significantly contribute to the overall educational experience.

SJCET's commitment to OBE and its dedication to improving the quality of education are commendable. Taking action based on faculty feedback is a proactive step toward achieving these goals. By implementing training programs, fostering industry-academia collaborations, and enhancing library resources, SJCET can continue to provide a holistic educational experience that prepares students for the challenges of the modern world.

ACTION TAKEN REPORT BASED ON THE FEEDBACK FROM FACULTY FOR THE ACADEMIC YEAR 2018-19

This institution is affiliated to APJ Abdul Kalam Technological University. The Board of studies prepares the curriculum based on the feedback and suggestions from the affiliated colleges through the conduct of meetings with Principals before preparing the curriculum.

For continuous improvement in the quality of course delivery, institution obtains feedback on curriculum design, course delivery and the support required by the students from the department and the institution. Based on the feedback collected from the Faculty. The following are the decisions taken by the institution.
