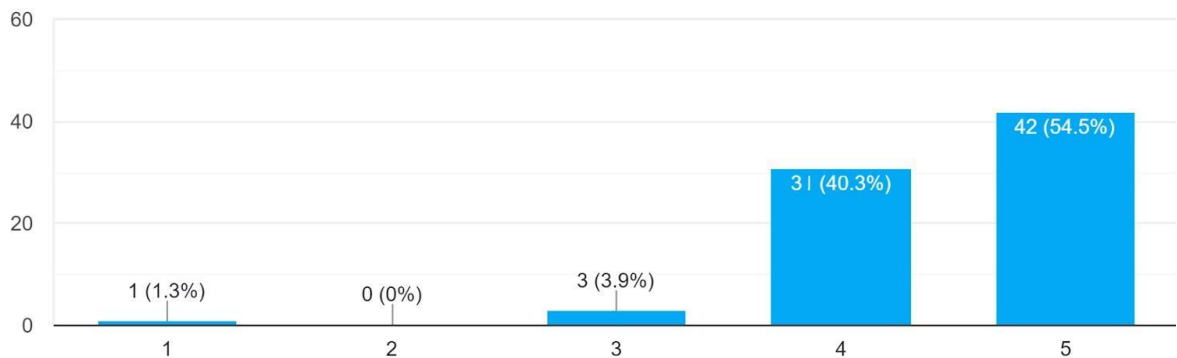

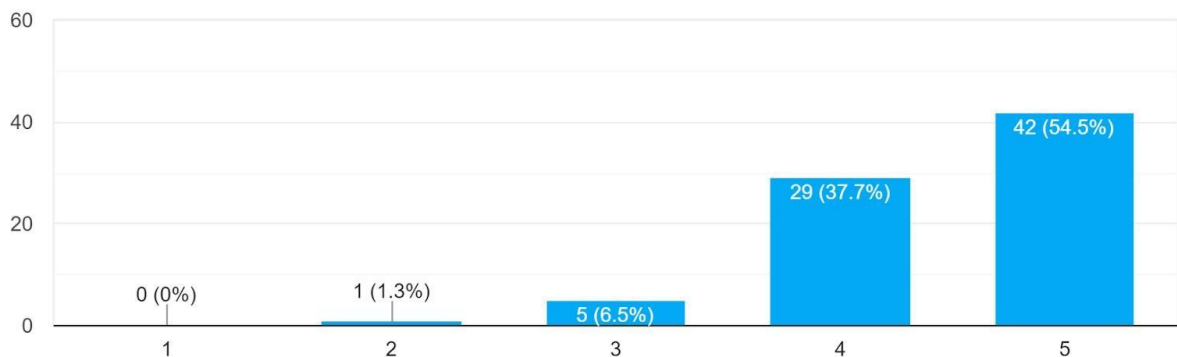

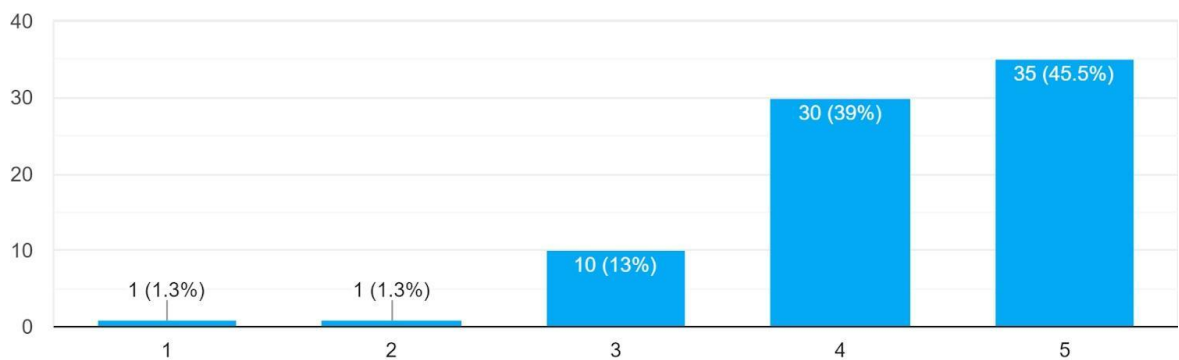

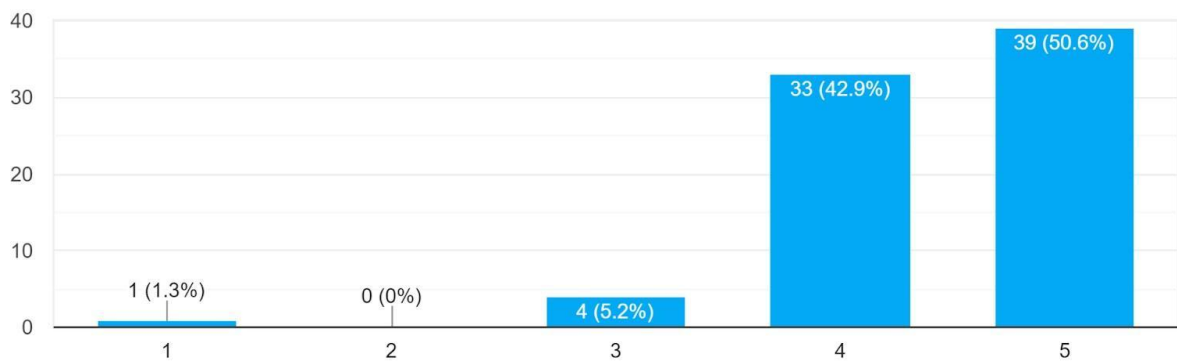

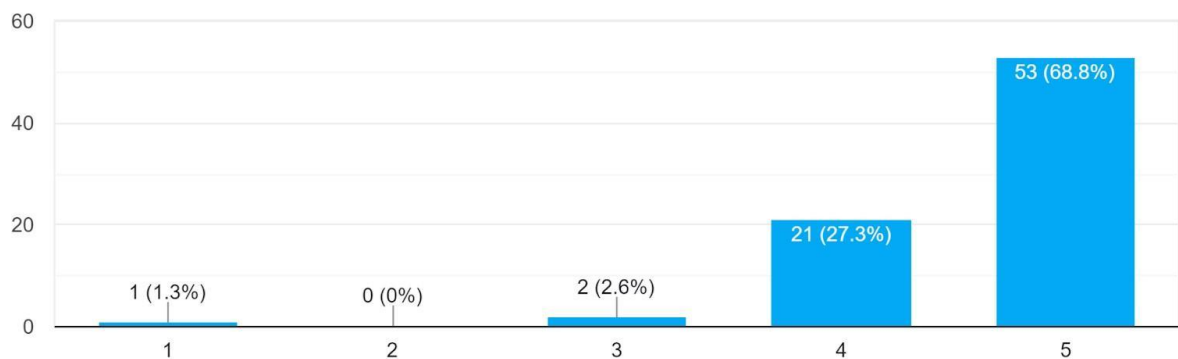

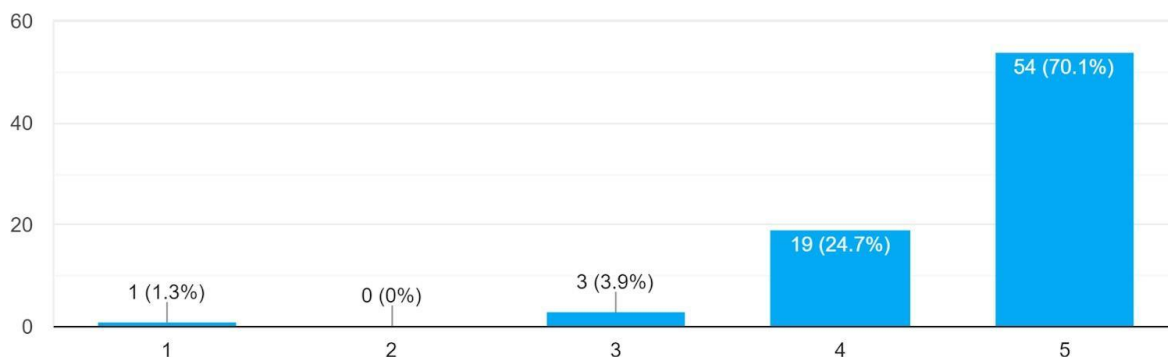

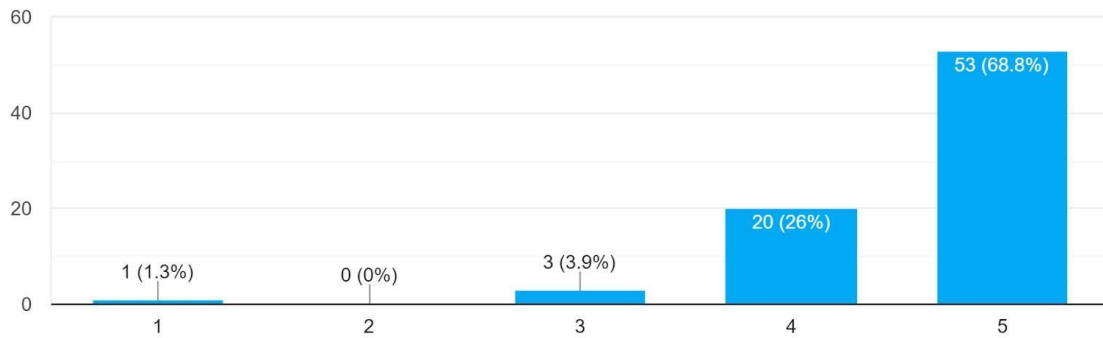

ACTION TAKEN REPORT BASED ON THE FEEDBACK FROM FACULTY FOR THE ACADEMIC YEAR 2021-22

This institution is affiliated to APJ Abdul Kalam Technological University. The Board of studies prepares the curriculum based on the feedback and suggestions from the affiliated colleges through the conduct of meetings with Principals before preparing the curriculum.

For continuous improvement in the quality of course delivery, institution obtains feedback on curriculum design, course delivery and the support required by the students from the department and the institution. Based on the feedback collected from the Faculty. The following are the decisions taken by the institution.

1. Co Po mapping given in the syllabus by the University is not well defined. This was further discussed in the Department BOS meeting and new Co Po was framed and sanctioned
2. As per the revised syllabus, laboratory sessions are given more to the students. Hence from 2020, there is balance between theory and practical sessions.
3. Revision of syllabus in every fourth year includes new courses. Faculties are advised to register for FDP's, NPTEL courses, coursera courses and also to handle sessions to students in the area of their excellence.
4. For skill upgradation and qualification enhancement, Faculties are advised to register for PhD program.
