





















#### **Summary of Faculty Feedback Analysis (2022-23)**

The analysis of faculty feedback at SJCET reveals several key findings and recommendations aimed at enhancing the quality of course delivery and faculty skill sets to align with the institute's commitment to Outcome-Based Education (OBE). The feedback mechanism at SJCET triggers action if more than 40% of the faculty disagree or strongly disagree with any specific question on the feedback form.

While some questions received responses below the 40% threshold, the institute remains proactive in addressing these concerns. This proactive approach stems from SJCET's dedication to improving course quality and faculty capabilities. The following summarizes the key findings of the faculty feedback analysis:

- Course Outcomes Definition: In some cases, course outcomes were found to be inadequately defined. Clearly defined course outcomes are essential for effective course delivery to students. Consequently, the institute may need to reframe course outcomes and ensure they align with the OBE framework, enabling instructors to better guide students towards achieving specific learning objectives.
- Faculty Development through NPTEL Courses: To facilitate continuous learning and the
  adoption of innovative teaching techniques, faculty members may be encouraged to register
  for courses offered by the National Programme on Technology Enhanced Learning (NPTEL).
  These courses can broaden faculty knowledge and help them incorporate new strategies into
  their teaching methods, ultimately benefiting students.
- 3. Support for Faculty Pursuing PhDs: In an effort to enhance faculty expertise and effectiveness in course delivery, SJCET provides support for faculty members pursuing their PhDs. This initiative recognizes that faculty with advanced degrees can bring a higher level of knowledge and research expertise into the classroom, leading to improved educational outcomes.

The faculty feedback analysis at SJCET underscores the institute's commitment to maintaining high educational standards and aligning with OBE principles. Addressing issues related to course outcomes, encouraging faculty development through NPTEL courses, and supporting faculty pursuing PhDs are crucial steps towards enhancing the quality of education and ensuring that students receive a well-rounded and impactful learning experience.
