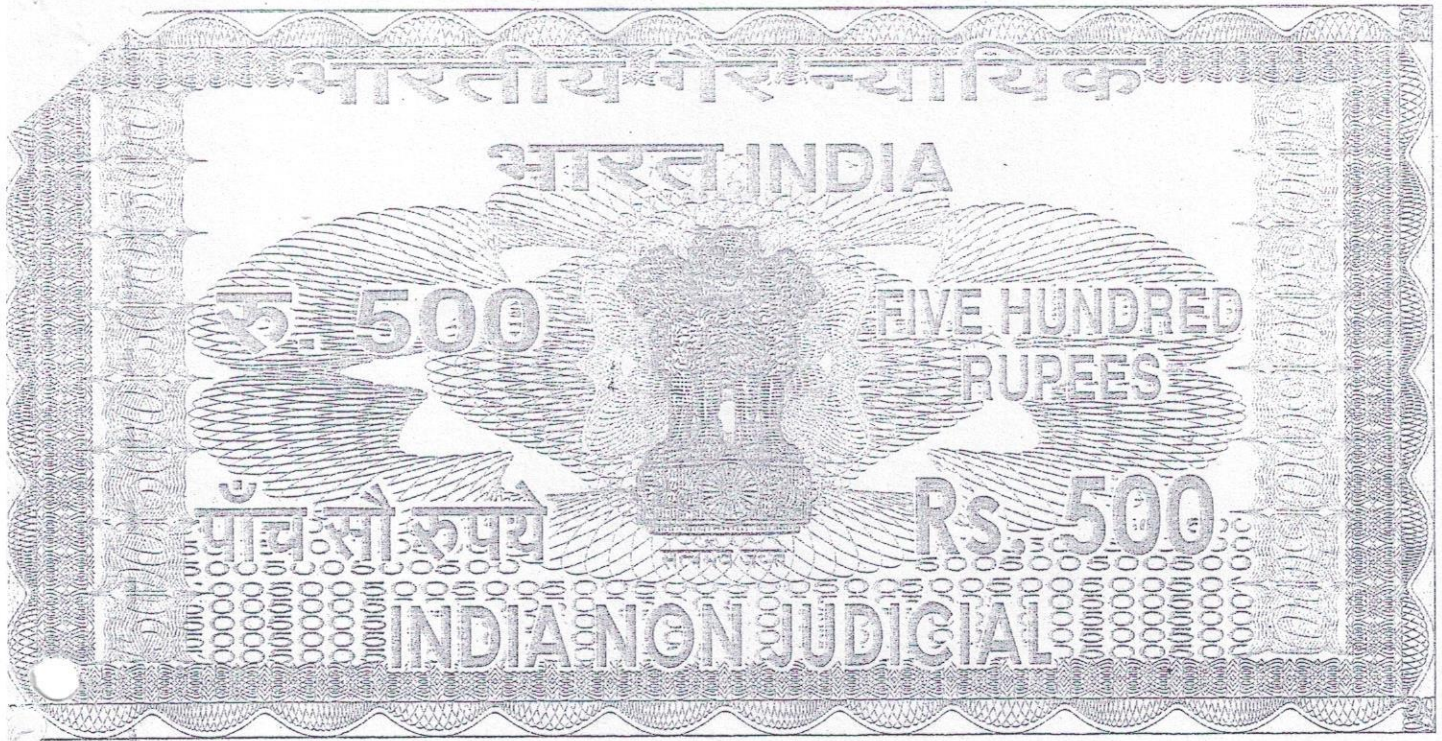

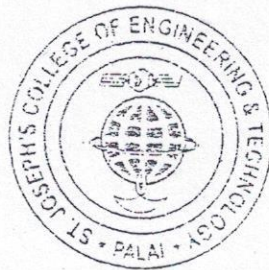
OBJECTIVE

RESOLUTION OF DISPUTES:

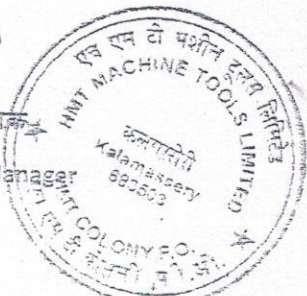
- a) This MoU shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the Courts at Ernakulam alone.
