1.3 DESIGN CONSULTANCY

1.4 SCOPE AND REMUNERATION

The scope, duration and remuneration of each engagement shall be on a case-to-case basis, on mutually agreeable payment terms.

1.5 CERTIFICATE

After completion of the course, certificates will be issued on behalf of SBSL and SJCET, based on formal report & evaluation.

2. EFFECTIVE DATE AND DURATION OF MOU

- a) This MoU shall be effective from the date of execution of this MoU.
- b) The duration of the MoU shall be for a period of Three years from the date of execution of this MoU.
- c) During its tenure, the MoU may be extended or terminated by a prior notice of not less than three months by either party. However, termination of the MoU will not in any manner affect the interests of the students who have been admitted to pursue a programme envisaged by this MoU.

- a) During the tenure of this MoU both SJCET and SBSL will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MoU for any purpose other than in accordance with this MoU.
- b) Both SJCET and SBSL shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this MoU.
- c) Both SJCET and SBSL shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.
- d) 'Confidential Information' shall mean any proprietary information, data or facts belonging to SJCET and SBSL collectively or severally, disclosed by the disclosing party under this MoU or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions. However confidential information shall not include any data or information which:
 - (i) is or becomes publicly available through no fault of the receiving party;
 - (ii) is already in the rightful possession of the receiving party prior to its receipt of such data or information;
 - (iii) is rightfully obtained by the receiving party from a third party or is in the public domain;
- e) Neither party shall assign any of its rights and benefits under this MoU to any other person without the prior consent in writing of the other.
